TRAVEL: Client agrees to cover ALL valet/parking expenses for on-location services, for myself and my assistant(s), if necessary.

CONTRACTED SERVICES PER PERSON: You may add additional people before the wedding date. Please give ample notice of a minimum of 7 days if you will be making changes to your bridal party, as your artist may need to hire an assistant to accommodate the extra services.

BOOKING DEPOSIT: A \$200 deposit is required to reserve your date. Deposit is due upon signing of this contract. I understand that this deposit is NON-REFUNDABLE if I decide not to use the service less than 90 days prior to my wedding date. By signing below, I acknowledge that my credit card account will be charged for 50% of the amount due above, plus processing fee (4% applies to credit cards).

RATES and SERVICES: *As per Bridal Services Menu (page 3).* Additional services required are listed below:

CONTRACTED DATE: I understand that if I cancel within 90 days prior to the date of service and, I will lose my deposit. If I give less than a month cancellation notice, the deposit plus half of the amount of the agreed upon services will be charged. If I cancel ***within 48 hrs*** of the service date, I will be subject to 100% of the fees due. Cancellation must be done in writing. Payment of the balance in full is expected on the contracted “date of service” by cash **ONLY**. Prior arrangements to pay in full for the services using a credit card are also accepted but must be arranged **in advance**. By signing below, I agree to & understand all the terms and conditions of this contract.
